## **Emissions reduction targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to **72 tonnes tCO2e by August 2028**. This is a reduction of 28%.

## **Carbon Reduction Projects**

#### **Completed Carbon Reduction Initiatives**

The following environmental management measures and projects have been completed or implemented since the 2023 baseline. The carbon emission reduction achieved by these schemes equate to 14 tCO2e, a 13.9% reduction against the 2023 baseline and the measures will be in effect when performing the contract.

Over the last 12 months these include:

- The introduction of a company-wide 'bike to work' scheme to encourage a reduction of car-based commuting.
- An increase in the use of working from home strategies.
- Conversion of company car fleet to electric.

In the future we hope to implement further measures such as:

- Introduce
- More localised recruitment to support reduced travel times
- Further use of working from home strategies
- Update our supply chain to encourage the use of carbon neutral providers for delivery, uniforms and technology supplies in particular
- Work towards a 100% digital / paperless office environment
- Requiring office staff / agency staff only to travel by public transport
